2008 Declaration

This declaration may be used by commercial businesses and agricultural property. It must be returned with the original Personal Property Business or Agricultural Statement. Additional filing information is on the reverse side of this form.

A business owner is entitled to an exemption from Personal Property taxation one time annually in the State of Arizona. For 2008, the exemption amount is \$63,242 of full cash value. If you feel you are entitled to the exemption, you may elect to complete this Declaration instead of providing the detail required by the 2008 Arizona Business/Agricultural Property Statement. After receiving this form from the taxpayer, the Assessor may require additional information. ***Per Arizona Revised Statutes all cost information is confidential but may be subject to audit.***

Personal Property is defined as all types of property except real estate. A sampling of Personal Property is listed below. ATTENTION TAXPAYERS WHO OWN COMMERCIAL BUSINESS PROPERTY AND/OR AGRICULTURAL PROPERTY

If you feel you are qualified for the Business or Agricultural Property Exemption of up to \$63,242 of full cash value, please do the following for an accurate assessment:

- Original forms must be completed and returned to our office no later than April 1, 2008. Non-original forms may result in an erroneous or duplicate assessment. If you elect and are qualified to utilize the Declaration on the reverse side of the form, please return original signed form with the Declaration.
- ***Commercial Business Property and Agricultural Property owners whose original cost exceeds \$60,000 and/or has more than one location in Arizona may not use the Declaration. The Arizona Business or Agricultural Form must be completed.***
- Identify the county where you wish to take the Business Property Exemption (Section 6 on back of the Arizona Property Statement). The exemption may be granted once annually, per taxpayer.
- Forms must have the signature of the owner or authorized agent, or they will be returned for signature (Section 6). Unsigned forms will be considered as not filed.
- If you elect to take your Business Exemption in Pima County, we require your Federal Employer Identification Number (FEIN) in order to calculate your Exemption. If the taxpayer does not have a FEIN, a unique number will be generated for you by this office.
